A Conversation with Descendants of a Displaced Black Community

June 7, 7 pm: Chevy Chase DC in the Arc of American History Register Now – Virtual Webinar

Join Historic Chevy Chase DC and the ANC 3/4G Committee on Race and Social Equity for a virtual webinar to hear directly from descendants of Black landowners who were displaced from Chevy Chase DC nearly a century ago. The program, titled "A Conversation with a Displaced Black Community: Chevy Chase DC in the Arc of American History," is free and will feature a special pre-recorded session between descendants and the Rev. William H. Lamar IV, pastor of Metropolitan AME Church in Washington, DC.

HCCDC's Charles Cadwell, a former ANC commissioner, will moderate a questionand-answer session at the end between the audience, the descendants, and the ANC 3/4G commissioners.

The program is an important part of a partnership between HCCDC and the University of the District of Columbia to explore multi-generational effects of Black land loss. HCCDC has been working with -- and learning from -- descendants of its African American neighbors on Broad Branch Road who were driven from their homes in the 1920s so a whites-only school and park could be built.

Two families among the descendant group have connections that go back to George Washington and Mount Vernon -- from slavery, to freedom, to nation building, to racial displacement. As part of its effort to rediscover and acknowledge this neighborhood history, HCCDC has gathered the stories of the descendants. Read about their stories on the HCCDC website here.

Department of Public Works Spring Reminder

Spring operations are well underway. For a complete overview of our spring services click here.

Residents are reminded to maintain any bush, shrub, or tree that extends from private property into public spaces including alleys. Residents who fail to keep public space free from obstruction may be assessed fees. In cases where property owners do not abate an overgrowth condition emanating from their property, DPW may take action to address safety & accessibility concerns. Please be aware the Department of Buildings also addresses private property matters with respect to overgrowth conditions.

The Sidewalk Shoveling Exemption application will open Monday, June 5, 2023, and remains open until October 31, 2023. District residents who are 65 years or older and/or have a recognized medical disability, own their own property, and reside in their property are eligible. Residents who have a medically recognized disability must provide proof of disability to be eligible. For eligible residents, the waiver is good for two years. Residents may apply for the Sidewalk Shoveling Exemption at dpw.dc.gov or by calling 311.

DPW will launch the *Curbside Composting Pilot Program*, which will provide weekly curbside food waste collection to 12,000 single-family households for one

year. Applications are still available for eligible households in Ward 1, 2, 7, and 8. Sign-up <u>here.</u> to participate.
